the owner of the Monument known as Bernera Barracks contained within a rectangular area of ground at Glenelg measuring 130 feet on each of its east-north-east and west-south-west sides and 115 feet on each of its north-north-west and south-south-east sides the north-west corner of said area being situated on the east margin of a road or track running north from Glenelg Village to join the road to Kylerhea Ferry at Galltair 880 feet south-west by south of the Glenelg River at its nearest point above high water mark and 860 feet north-west of Bench Mark 27.5 on the south-east side of the road running north-east from said Village to join the public road from Kylerhea to Shiel Bridge

being the subjects indicated in red colour on the annexed plan and being part of the property known as the lands and Barony of Glenelg and others,

situated in the Parish of Glenelg and
County of Inverness

In accordance with the provisions of Section 6 of the Ancient Monuments Act, 1931, the Minister of Works hereby give you notice that it is his intention to include the Monument above specified in a list of monuments to be published by him under Section 12 of the Ancient Monuments Consolidation and Amendment Act, 1913.
